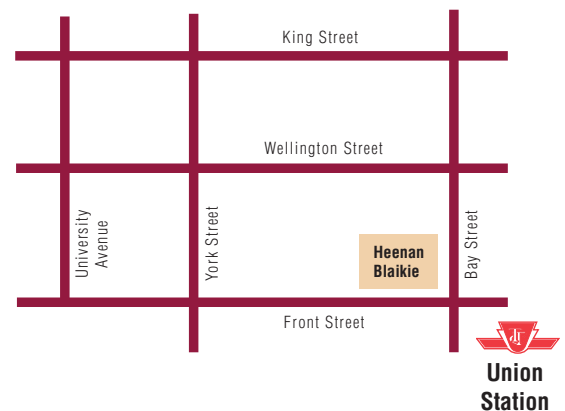

Priscilla is a founding member of the Privacy Law Sections of both the Canadian Bar Association (CBA) and the Ontario Bar Association (OBA), and has served as Chair of both Sections. She is a member of the executive of the OBA's Privacy Law and Public Sector Lawyers Sections. She is co-author with Adam Kardash of Heenan Blaikie's electronic guide to FIPPA and MFIPPA, available at [www.accessprivacy.ca](http://www.accessprivacy.ca).

On June 20, 2006, Priscilla was awarded the first **Karen Spector Award for Excellence in Privacy Law** by the Ontario Bar Association. The award was presented to Priscilla in recognition of her exceptional contributions and achievements in the practice of privacy law. Since 2007, Priscilla has been an adjunct professor of *Information Law* at the University of Toronto Law School.
